# 1. The city of Ljubljana and how to get there

## 1.1. THE CITY

Ljubljana lies in a basin between the Karst and the Alps, some 298 m above sea level. We like to say that it is big enough to encompass everything one would expect from a capital city, while being small enough to allow people to retain their individuality.

Ljubljana is a pleasant city to live in. The city is home to 283,000 people. Although it is not among Europe's largest cities, it has everything one finds in other capitals: museums and galleries, one of the oldest philharmonic orchestras in the world, other orchestras, many theatres, a university, institutes and libraries.

The city's increasingly vibrant commercial and trading life and the rapid increase in foreign diplomatic representatives are giving it an ever greater cosmopolitan touch. It offers a wide variety of cafes, pubs, bars and restaurants. Relief from the hustle and bustle of life in the capital can be found in the numerous parks and woodland areas, which in some places reach nearly into the city centre.

## 1.2. HOW TO GET THERE

### **AIR:**

Ljubljana Jože Pučnik Airport, 20 km from the centre of Ljubljana, has good connections with other European airports. Airport shuttle buses take passengers to the centre of town.

## 2. University of Ljubljana

University of Ljubljana is an institution with a very rich tradition. With more than 40.000 students participating in 374 bachelor, master and doctoral degree programmes, it ranks among the largest universities in the world. A total of 23 faculties and three art academies employ approximately 6000 full-time higher education teachers, researchers, assistants and administrative staff.

The University of Ljubljana was established in 1919 on the foundations of a long-established pedagogical tradition. For almost half a century it remained the only Slovenian university until joined, about 20 years ago, by the University of Maribor. In 2003 the third Slovenian University was established in Koper, University of Primorska.

The University has its seat in Ljubljana, Slovenia's capital. Nearly one tenth of Ljubljana's inhabitants are students, which gives the city a young and lively character.

The University was founded in the centre of Ljubljana, where the central university building and the majority of its departments are located. Later on, some new, modern buildings were constructed in the suburbs.

# 4. University of Ljubljana grading system

GRADE	GRADE DESCRIPTION
10	<b>excellent:</b> exceptional results with negligible faults
9	<b>very good:</b> outstanding knowledge but showing some faults
8	<b>very good:</b> solid results
7	<b>good:</b> good knowledge but showing some major faults
6	<b>adequate:</b> knowledge meeting minimum criteria
5-1	<b>inadequate:</b> knowledge not meeting minimum criteria

A candidate successfully completes an exam if he/she receives a grade between adequate (6) and excellent (10).

*Performance at exams in doctoral studies can also be evaluated with the following grades:*

- failed;
- passed;
- passed with distinction.

The specific methods of assessing performance in exams in doctoral studies are set out in the respective doctoral degree programmes.

*ECTS credits:*

- 1 full academic year = 60 credits;
- 1 semester = 30 credits.



# 5. Academic calendar

<b>Autumn Semester</b>	beginning of October – middle of January
<b>Spring Semester</b>	middle of February – end of May
<b>Winter holidays</b>	middle of January – middle of February
<b>Winter examination period</b>	middle of January – beginning of February
<b>Summer holidays</b>	beginning of July – end of August
<b>Summer examination period</b>	beginning of June – end of June
<b>Autumn examination period</b>	end of August – middle of September

In the Republic of Slovenia, academic year starts on 1 October and ends on 30 September. Every year, the study calendar specifies the duration of organised study activities, examination periods, school holidays, public holidays and of the university week. The academic calendar may differ from one University member to another. Please check the website of a particular University member (academy / faculty) for details.

# 7. Slovenian language courses

Students in the Erasmus+ exchange program are offered an intensive Slovenian language course before starting the winter or summer semester. The Centre for Slovene as a foreign language, Faculty of Arts, organizes a 60 hours (3 ECTS) intensive Slovenian language course for Erasmus+ students. The course fee is 75€ and the places are limited (the “first come first served” principle).

The application deadlines are in June for the course starting in September and in December for the course starting in January.

# 8. Student organisation

- sports;
- international co-operation;
- other extracurricular activities.

The Erasmus Student Network (ESN) is a group of students at the University of Ljubljana forming a part of ESN International. ESN's main task is to participate in the receiving of exchange students, including mentorship, sightseeing and social gatherings.

ESN and international office of ŠOU organise hikes, trips, excursions and parties. All exchange students are invited to take part in these arrangements. # 9. Accommodation

- to rent a room that is part of the Student residence halls (a very limited number of beds!), apply through an online application.

The International Office can help you with providing rooms in the Student residence halls, but due to the shortage of rooms, we cannot guarantee that you will really get a bed. All rooms in Student residence halls are double-bedded rooms. They are furnished and have a shared kitchen and bathroom.

We strongly advise our students to book some temporary accommodation for the first few weeks of their stay in Ljubljana and then look for private accommodation.

# 10. Application procedure for exchange

If you wish to undertake a period of study at the University of Ljubljana, you should contact the Office of International Relations ([intern.office@uni-lj.si](mailto:intern.office@uni-lj.si)) to request the application information, which is also available on this website:

## 10.1. LEARNING AGREEMENT

This document is an agreement between incoming students and the host institution. Students select the subjects they wish to study in consultation with their academic advisor at their home institution. The draft proposal is then uploaded to the online application. The options the student has selected are then considered by the University of Ljubljana on the basis of availability and the candidate's ability and academic background. A decision is then forwarded to the candidate and, if both sides are in agreement, the document is considered as a contract. However, departments do have the right to withdraw their courses at any time before the study period begins.

## 10.2. TRANSCRIPT OF RECORDS

This document has two functions. Firstly, it is used by departments to make decisions about a candidate's suitability based on the information supplied on the transcript of records. The transcript functions as a formalised curriculum vitae or resume.

The certificate presented to students upon the completion of their studies in Ljubljana is also known as a transcript. It outlines the courses taken and the grades achieved.

## 10.3. LANGUAGE REQUIREMENTS

The University of Ljubljana offers instruction in the following languages: Slovenian and English. The University of Ljubljana requires that the student has very good language skills (very good knowledge in reading, writing and speaking of the language) in at least one of the two languages in order to be able to study here.

Please note that fluent language skills in Slovenian (or English) are vital for successful studies at the University of Ljubljana. If the language requirements are not met, the University of Ljubljana will not accept you.

## 10.4. REQUIRED LANGUAGE SKILLS

Students must present a language certificate of their Slovenian or English language skills. Very good language skills refer to level B2 on the CEFR scale of the European Language Portfolio Levels.

### How to prove the language skills in Slovenian or English:

- language skills are listed on the Transcript of Records of the home university; or
- submit the Language Certificate with CEFR scale; or
- submit TOEFL score of 79 (IBT) or IELTS score of 6 for English or any other official certificate; or
- submit the result of the OLS (Erasmus+ online language support).



# 11. Useful information

## 11.1. TEMPORARY RESIDENCE PERMIT

### *Entry and residence of EU citizens*

Valid personal identity document (passport or personal identity card) is sufficient to enter the Republic of Slovenia.

Entrants may stay in the territory of the Republic of Slovenia for up to 90 days of their entry in the country, however they are obliged to report the temporary address to the Police or relevant administrative unit (in Ljubljana: **Tobačna ulica 5, 1000 Ljubljana, Slovenia**).

In the event of exceeding 90 days, residence permit is obligatory. This can be obtained from the administrative office within the residential district (in Ljubljana: **Administrative Unit Ljubljana, Administrative Internal Affairs, Department for Foreign Citizens** (Upravna enota Ljubljana, Sektor za upravne notranje zadeve, Oddelek za tujce), Tobačna ulica 5, 1000 Ljubljana, Slovenia, every day during office hours: Mondays, Tuesdays and Thursdays 8 a.m. - 6 p.m., Wednesdays 8 a.m. - 7 p.m., and Fridays 8 a.m. - 2 p.m.).

The temporary residence permit will be issued in accordance to the conditions set by the European Union. In order to issue a residence permit to a citizen from a member state for the purpose of study the following conditions have to be met:

- valid identity card or a valid passport;
- evidence of admission to study;
- evidence of appropriate health insurance;
- evidence of sufficient funds for subsistence. Signed statement suffices as proof of sufficient funds for subsistence;
- personal photo (35 x 45mm).

Copy of the student's passport or identity card must be certified by a notary or at the registry of the Department for Foreign Citizens.

According to the stated directive the residence permit is granted for the period of studies or at the most for one year and can be extended in the event that the studies last for over a year.

### *Entry and residence for citizens of non-EU countries*

The first temporary residence permit for non-EU citizens may be issued after entry into Slovenia under certain **conditions** stipulated by law to the following foreigners:

- researchers, college/university teachers or college/university associates who have concluded a hosting agreement and are lawfully residing in Slovenia on the basis of a valid passport or identity card (where no visa is required), C visa or a valid residence permit issued in another EU member state;
- international students who are lawfully residing in Slovenia on the basis of a valid passport or identity card (where no visa is required), C visa or a valid residence permit issued for study purposes in another EU member state, or D visa issued for study purposes in another EU member state.

Within the 90 day period or after the expiration of Visa D, they are obliged to apply for a first residence permit at the relevant administrative unit in Slovenia (in Ljubljana: **Administrative Unit Ljubljana, Administrative Internal Affairs, Department for Foreign Citizens** (Upravna enota Ljubljana, Sektor za upravne notranje zadeve, Oddelek za tujce), Tobačna ulica 5, 1000 Ljubljana, every day during office hours: Mondays, Tuesdays and Thursdays 8 a.m. - 6 p.m., Wednesdays 8 a.m. - 7 p.m., and Fridays 8 a.m. - 2 p.m.).

The non-EU citizens who have a **valid residence permit** issued by **another state that is party to the Schengen Agreement**, may enter the Republic of Slovenia on the basis of this permit and a valid travel document and stay there for no longer than three months in a six-month period, which includes the combined duration of their stay in all Schengen States except for the state which issued the visa, starting on the date of the first entry into one of Schengen States or until the expiry of visa validity if this is shorter. Within 90 days period, they are obliged to apply for first residence permit at the relevant administrative unit in Slovenia (in Ljubljana: Tobačna ulica 5, 1000 Ljubljana).

**For first residence permit application they are required to possess the following:**

- personal photo sized 35 x 45mm showing the real image of the applicant that is made in colour and fit for biometric documents;
- two fingerprints;
- evidence of admission to study, education, specialisation or professional training in the relevant educational establishments in the Republic of Slovenia;
- evidence of appropriate health insurance in the Republic of Slovenia;
- evidence of ensured funds for subsistence (sufficient proof of the fulfilment of the requirement for sufficient funds for subsistence (in the minimum monthly amount of the basic minimum income in the Republic of Slovenia) is a written statement made by the student's parents or legal guardian indicating that they would provide means for the student's subsistence. A foreign citizen may prove the fulfilment of the requirement for sufficient funds for subsistence in any other way, and the evidence will be assessed in a declaratory procedure);
- valid passport with validity extending beyond the planned period of residence in the Republic of Slovenia by at least 3 months (a copy is certified by a notary, administrative unit or the registry of the local department – the copy and valid passport is enclosed for inspection);
- police clearance certificate not older than three months issued by the home country (if the country in question issues it), translated into Slovenian, and verified.

## 11.2. HEALTH INSURANCE

International students coming from **EU and EEA Member countries and Switzerland** have free access to emergency or necessary healthcare services during their temporary residence in the Republic of Slovenia upon submission of evidence of their status: the European Health Insurance Card (EHIC) or a certificate as a substitute for EHIC that is issued by the competent state. This means that the doctor has to provide necessary healthcare services to students who hold a European health insurance card so that they do not have to return to their home country for medical care before the end of their intended stay in Slovenia. Students can access the services directly from health care service providers who have a contract with the Health Insurance Institute Slovenia. During their stay in Slovenia, students with valid health insurance in **Australia** can assert only urgent medical care with health care providers, which wave a signed agreement with the Health Insurance Institute Slovenia. They must present their MEDICARE Australian card and passport used to check the identity of the insured person from Australia.

International students from countries with which the Republic of Slovenia has concluded a bilateral agreement on social insurance have free access only to emergency healthcare services in the Republic of Slovenia upon submission of evidence of their status. The Republic of Slovenia has concluded bilateral Social Insurance Agreements with the Republic of Macedonia, Republic of Bosnia and Herzegovina, Republic of Serbia, and Montenegro. As a rule, a foreign insured person must submit sample form RM/SI 3, BIH/SI 3, SRB/SI 03 or MNE/SI 03 to the regional unit of the Health Insurance Institute Slovenia. The Health Insurance Institute Slovenia issues a certificate which allows students access to emergency medical services from healthcare service providers who have a contract with the Health Insurance Institute Slovenia.



Exceptionally, i.e. in cases of major emergency, a foreign insured person may exercise their right to healthcare services with one of the above mentioned forms directly at the doctor's office and medical institutions.

Persons from **non-EU and non-EEA countries, Switzerland or from countries with which Slovenia has not concluded bilateral agreements** on social insurance can take out their compulsory health insurance policy at one of the local units of the Health Insurance Institute Slovenia. Upon registering for this compulsory health insurance policy, students have to submit a certificate that confirms they are enrolled in an educational programme in Slovenia. The registration and the payment of the policy's cost are the responsibility of the student.

Notably, based on their inclusion in the insurance system of Slovenia, international students have free access to health care services within the scope of compulsory health insurance. Considering that they are required to cover the difference to the full price of healthcare services themselves, it is recommended that they also take out supplementary health insurance at a commercial insurance company (Vzajemna: [www.vzajemna.si](http://www.vzajemna.si), Adriatic Slovenica: [www.adriatic-slovenica.si](http://www.adriatic-slovenica.si), Triglav: [www.triglav.si](http://www.triglav.si)).

### 11.3. STUDENT IDENTITY CARD

Student identity card is evidence of student status. Students use the identity card to exercise their rights and to obtain other benefits deriving from the student status (subsidised student meals, discounts on entrance fees to museums and other visits, etc.). Students receive their identity cards at the relevant University Member (academy or faculty).

### 11.4. PERSONAL REGISTRATION NUMBER (EMŠO)

The Personal Registration Number (EMŠO) is a personal identification number in the Republic of Slovenia. International students are assigned the personal EMŠO at the relevant University Member (academy / faculty).

### 11.5. TAX IDENTIFICATION NUMBER

International students require tax identification number to open a bank account (to work via a student job centre, receive a scholarship from a Slovenian institution, etc.).

International students may obtain a tax identification number at the tax office.

## 11.6. BANK ACCOUNT

International students may open a bank account in almost any bank in the Republic of Slovenia.

International students having a residence permit may open a resident bank account; others may open a non-resident bank account (SKB, NLB, Gorenjska Banka, Addiko bank, UniCredit Bank, Hranilnica Lon, Poštna banka Slovenije, Abanka, Banka Koper, etc.).

Most shops, hotels and restaurants accept Eurocard, VISA, Mastercard, Diners Club, American Express and other payment cards.

## 11.7. STUDENT WORK OPPORTUNITIES

International students studying in Slovenia and having a student status may work via student job centres or, rather, a job referral note under the same terms as Slovenian citizens.

The options and terms of student work are the same for students who are EU citizens and third-country citizens. The only difference may lie in the taxation of citizens of different countries, as it depends on a particular international agreement concluded between Slovenia and the relevant country.

Students, citizens of EEA or third-countries must have a registered place of residence to work as students.

To work during study, student must be a member of a particular student job centre. Application for membership must include:

1. personal identity document;
2. evidence of student status;
3. Personal registration number (EMŠO);
4. Slovenian tax identification number;
5. Slovenian personal transaction account number;
6. signed statement of (non-)residence.

## 11.8. LIVING EXPENSES

Living expenses (rent, food, public transport, books) in the Republic of Slovenia roughly amount to €500 per month; actual expenditure depends on individual lifestyle.

## 11.9. SUBSIDISED STUDENT MEALS

All students are entitled to subsidised student meals.



To use this subsidy, students are required to submit an online application form through the [www.studentska-prehrana.si](http://www.studentska-prehrana.si) portal and then report to the nearest Subsidised Student Meal point the num-
